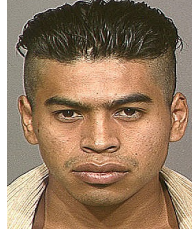

 May be traveling between the Phoenix area and Pinal County.



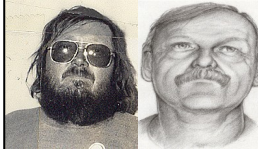
JOSE R. TORRES
