**HeinOnline** A searchable archive of legal materials converted to electronic format, including Code of Federal Regulation, English Reports, European Center for Minority Issues, Federal Register Library, Federal Legislative History Library, Law Journal Library, Legal Classics, Treaties and Agreements, US Attorney General opinions, US Presidential Library, US Supreme Court Library, US Statutes at Large. Individual HeinOnline libraries are listed below.

**Index to Legal Periodicals** Index with full text links to more than 1,000 English language legal journals, law reviews, yearbooks, institutes, statutes, bar association publications, university publications, and government publications from 1981 to the present. Articles from 1918-1981 are searchable in Index to Legal Periodicals Retrospective.

**National Criminal Justice Reference Service Library** Summaries of more than 190,000 documents on criminal justice, juvenile justice, and substance abuse resources, including Federal, State, and local government reports, books, research reports, journal articles, and unpublished research.

**NCJRS News: JustInfo** Newsletter of the National Criminal Justice Reference Service; highlights information from criminal justice agencies.

**Bar Journals** Contains more than 70 state and local Bar Journals. You can search by article title, author, description, date, or across the full text of the articles available through HeinOnline.

**Class Action Litigation Report** Developments in class action and multiparty litigation, including court cases, legislation, court rules, pre-trial developments, bench rulings, unreported decisions, settlements, attorney fee petitions, motions and pleadings, expert analysis and practice tips. Available in the Library and Court complex only.

**Code of Federal Regulations** General and permanent rules published in the Federal Register by the executive departments and agencies of the Federal Government; available through HeinOnline.

**Criminal Justice Periodicals** U.S. and international criminal justice journals, including information for professionals in law enforcement, corrections administration, drug enforcement, rehabilitation, family law, and industrial security; some with full text. Available in the Library and Court complex only.

**Criminal Law Reporter** Summaries of court decisions, news articles and extensive coverage of the U.S. Supreme Court in the areas of criminal law and procedure. Available in the Library and Court complex only.

**Employment Discrimination Report** All areas of EEO policy and practice, key cases from all levels of U.S. courts; articles on new developments and emerging trends; summaries of briefs filed by the EEOC; important jury verdicts, monetary settlements, and consent decrees; alternative dispute resolution. Available in the Library and Court complex only.

**English Reports (1220-1865)** Original reports of 100,000 cases, representative of 265 separate series of reports, arranged by courts; available through HeinOnline.

**European Center for Minority Issues** Includes ECMI reports and working papers, Journal on Ethnopolitics and Minority Issues in Europe, and Ombudsman Institutions and Minority Issues: A Guide to Good Practice; available through HeinOnline.

**Federal Register Library** The official daily publication for rules, proposed rules, and notices of Federal agencies and organizations; executive orders and other presidential documents; available through HeinOnline.

**Law Journal Library** HeinOnline Law Journal Library is a collaborative ongoing effort of William S. Hein Co., Inc., Cornell Information Technologies and the Cornell University Law Library to convert the text of all back issues of indexed law journals into a searchable electronic format; available through HeinOnline.

**Legal Classics Library** Classic legal texts such as Blackstone's Commentaries (1803), Bouvier's Law Dictionary and Concise Encyclopedia (1914), De Jure Naturae et Gentium Libri Octo (1688), Federalist Special ed. (1788), On Civil Liberty and Self-Government Enl. ed. (1859), Writings of John Marshall, Late Chief Justice of the United States, upon the Federal Constitution (1839); available through HeinOnline.

**LLMC-Digital** Extensive collection of legal literature and government documents, including U.S. Federal executive, legislative, and judicial resources, state court reports, and international materials. Available in the Library and Court complex only.

**Loislaw** Includes Aspen Evidence Library, Aspen Family Law Library, Aspen New York Family Law Library, Arizona Bar titles, Illinois Family Law Forms. Available in the Library and Court complex only.

**Manual of Patent Examining Procedure** Patent laws and rules published by the U.S. Patent and Trademark Office. Available through HeinOnline.

**Session Laws Library** Session laws of all 50 U.S. states as well as Canada, Australia, Puerto Rico, Virgin Islands, and the D.C. Register. Available through HeinOnline.

**Subject Compilations of State Laws** Comprehensive source for identifying thousands of articles, books, government documents, loose-leaf services, court opinions and Internet sites that compare state laws on hundreds of subjects. Available through HeinOnline.

**Treaties and Agreements Library** United States Treaties and Other International Agreements, Treaties and Other International Agreements of the United States of America 1776-1949 (Bevans), Treaties, Conventions, International Acts, Protocols and Agreements (Malloy), Treaties and Other International Acts of the United States of America (Miller), KAV Agreements, Treaties in Force, Guide to Treaties in Force; available through HeinOnline.

**U.S. Attorney General Opinions** Includes Official Opinions of the Attorneys General of the United States, Opinions of the Office of Legal Counsel of the United States Department of Justice, Attorney General. Annual Report. U.S. Department of Justice, Attorney General's National Committee to Study the Antitrust Laws; available through HeinOnline.

**U.S. Code Library** Comprehensive coverage from HeinOnline; browse by edition or title; includes citation search tool.

**U.S. Federal Agency Documents, Decisions and Appeals** Includes reports from agencies such as National Labor Relations Board, Copyright Office, and IRS, as well as GPO "Best Sellers" like Annual Energy Outlook, Compilation of Social Security Laws, Federal Rules of Civil Procedure with Forms. Available through HeinOnline.

**U.S. Federal Legislative History Library** Federal legislative histories and Sources of Compiled Legislative Histories (Johnson); available through HeinOnline.

**U.S. Law Week** National coverage of significant cases and key legislative and regulatory developments across all areas of the law, summaries of selected federal court, state court and administrative cases. Available in the Library and Court complex only.

**U.S. Presidential Library** Includes Messages and Papers of the Presidents, Public Papers of the Presidents, CFR Title 3 (Presidents), Weekly Compilation of Presidential Documents, and other documents related to U.S. presidents.; available through HeinOnline.

**U.S. Statutes at Large** Contains the text of all laws and resolutions passed by Congress from 1789 to 2006, along with treaties to 1949 and Revised Statutes of the United States (1873-1874).

**U.S. Supreme Court Library** Includes U.S. Reports (1754-2004), U.S. Reports Preliminary Prints (2002-2006) and U.S. Reports Slip Opinions (2002- ), Rules of the Supreme Court of the United States (1890-2006), Constitution of the United States of America, Supreme Court Economic Review (1982-1997), Supreme Court Review (1960-1998), and numerous books on the Supreme Court. Available through HeinOnline.

**Westlaw Patron Access** Westlaw Patron Access provides access, with KeyCites, to all state and federal cases and to state statutes and administrative materials. It also includes journals, law reviews, jury verdicts for all 50 states, legal forms from over 20 states, topical legal forms (such as Arizona Legal Forms, AmJur Pleading and Practice Forms), and selected treatises (such as AmJur Proof of Facts, AmJur Trials, Restatements of Law, American Law Reports, and the Arizona Practice Series).

**World Trials Library** Trial transcripts, court documents, analyses of important trials, biographies of trial lawyers; includes American State Trials, Howell's State Trials, Law Reports of Trials of War Criminals, Reports of State Trials, Sixty Famous Cases, as well as the full trial collection from Cornell University Law Library.
