Commissioners Richard Albrecht and Stephen Kupiszewski and Lou Vergne, a third member of their team, completed a half Iron Man triathlon on October 22 on the heels of open heart surgery.

Both commissioners had surgery within the past year, and Vergne was operated on about two-and-a-half years ago.

All three men had some notable finishes. Commissioner Kupiszewski completed a 1.2 mile swim, finishing 5th out of 85 people in the 45-49 age group. Vergne placed 1st of 38 in the 50-54 age group in the 56 mile bike ride and Commissioner Albrecht placed 7th out of 26 in the 55-59 age group in the 13.1 mile run.

“When we were compared to all relay teams, even those much younger, we still placed 36th out of 69 teams,” Commissioner Kupiszewski said.
