Each June, when our judges and commissioners are attending the statewide judicial conference hosted by the Arizona Supreme Court, our Court performs judicial rotations.


Rotations are done during the judicial conference because it creates the least amount of disruption to our court customers.

## Chief Juvenile Probation Officer Appointed

The Judicial Branch of Arizona in Maricopa County announces the appointment of Vincent Iaria as Chief Juvenile Probation Officer.

Iaria will oversee 850 staff members who are responsible for programs that provide community supervision for approximately 4,500 youth on probation. He replaces Deputy Chiefs Debra Hall and Debra Olsen who filled-in as interim Co-Chiefs.

His knowledge in juvenile probation will benefit the children, youth and families in our community," Presiding Judge Barbara Rodriguez Mundell said. "His work with various community-based organizations will be a huge asset for the Judicial Branch of Arizona."

### Governor Appoints Chris Coury to Superior Court Bench

Governor Jan Brewer today announced the appointment of Christopher Coury to the Maricopa County Superior Court.

Chris Coury is a partner with the law firm Ryley Carlock & Applewhite, where he has worked since 1999. Prior to that he worked for the Maricopa County Attorney's Office from 1996 to 1999, and the law firm O'Connor Cavanagh from 1995 to 1996. He clerked for Judge Edward Voss at the Arizona Court of Appeals from 1994 to 1995. Chris graduated from the University of Notre Dame Law School in 1994, and received his undergraduate degree from Notre Dame in 1991.

Chris's current law practice consists of commercial cases, securities fraud, banking law, contract and consumer fraud. At the Maricopa County Attorney's Office he practiced in the area of criminal law for several years prosecuting cases ranging from misdemeanors to felonies and gang cases. Chris is a third-generation Arizonan who has donated generously of his time to numerous community organizations and proudly serves as a coach of the Scottsdale Soccer League team the Sharks.

"Chris Coury's impressive background in civil and criminal law make him well qualified to serve as Maricopa County Superior Court's newest judge," stated Governor Brewer. "Chris is thoughtful, deliberative and caring, and I am certain he will work diligently to assure that justice is administered fairly to all who appear before him." This appointment was made to fill the vacancy created by the retirement of the Honorable Robert C. Houser.

Prior to his appointment, Iaria served as Acting Bureau Chief for Los Angeles County Probation Department.

During his career, he served as the Director of Probation for Suffolk County Probation Department in Yaphank, New York. He also worked in San Diego as the Chief Probation Officer for San Diego County Probation Department.

Associate Presiding Judge Norman Davis said, "Mr. Iaria was chosen from an extremely qualified and diverse field of excellent candidates. We are very fortunate to have a new probation chief with the vast experience and knowledge that Vincent Iaria possesses. # Board of Supervisors Recognizes Employees with 30 Years of Service

*Below are the scripts read during the Board of Supervisors ceremony honoring employees.*

### **Scott Loos, Court Interpretation and Translation Services**

Scott began his employment with the Court in 1978 as a contractor and became a full time staff interpreter on August 28, 1979 and has served continuously since then. Scott has a fierce dedication to the interpreting profession and, as such, he has set and maintained high standards in the recruiting and training of interpreters. He has created an office that is highly regarded for its professional standards and interpreting ability which has earned him much deserved respect and admiration for his work and professionalism. Scott received a Commendation of Excellence from the South Carolina Commission on Higher Education in 2001, an award for interpreter training from NACo in the 1990s and a special recognition from the Arizona Court Interpreters Association for professional enrichment and training in 1988 and 2009. He is a member of the American Translators Association and Arizona Court Interpreters Association and he serves on the rating panel for the Federal Interpreters Exam. He is a former instructor at the College of Charleston, Montclair State College, University of Houston and Arizona State University.

Scott is extremely knowledgeable and an excellent researcher. His training, tutelage and mentoring is credited by many of the staff for developing their skills and abilities, for which they are very grateful. He prepares training courses and classes for the department so that all of the interpreters have an opportunity to develop their own skills. He is dedicated to the profession and takes pride in being a prepared and skilled interpreter and he does his best to instill those values in others within the department as well. Scott is patient and willing to take time to explain, correct, revise and direct the work of his colleagues. Scott also has a wicked sense of humor that helps the staff get through the day-to-day business of running from courtroom to courtroom and dealing with the myriad of issues that arise.
