The Summit will be held November 3-4, 2011 at the Lodge in Oak Brook, Illinois.

## Court Hires Jury Administrator

Superior Court hired Candace Atkinson as its new Jury Administrator. Prior to her work at the Federal Court, she was Court Administrator for the Greeley Municipal Court in Colorado.

## Remote Interpreter Program

The remote interpreter program allows the court to provide an interpreter to over 25 courtrooms throughout Maricopa County in all areas of the law from a remote location. The program has increased the interpreters' productivity, provided a means to satisfy the increasing demands, and improved the utilization of resources.

## Backlog FARE

Backlog FARE addresses the need to collect monies owed to the justice courts that have been uncollected. The program also makes it easier for citizens to pay monies they owe. Backlog FARE utilizes the transmission of electronic case and financial data between the administrative office of the courts, motor vehicle department and state courts to ensure applicable obligations are met and have increased collections from about \$300,000 to \$500,000 per month.



## Probation Re-entry Initiative



Over 100 offenders per month are released from prison with a consecutive probation sentence in Maricopa County. A specialized re-entry unit implemented a new supervision model, collaborated closely with the Arizona Department of Corrections and community-based service providers, and dramatically improved the re-entry process, achieving noteworthy reductions in recidivism.

## 2011 NACo awards

### Juvenile Court Community Services Unit



The community services unit began development in 2006 with the establishment of the juvenile court guide program. Over the next several years, the CSU became fully formed with the collaboration of internal and external partners. The CSU is composed of representatives from child welfare, behavioral health, court conciliators, court guides, and early intervention staff. Additional collaborative partners include: court operations, and volunteer lawyers and law students. The CSU is available to the public as a “one stop shop” for information, referral services, and limited free legal advice.

### Juvenile Court Guide Program

The juvenile court guide program was established in 2006. The court guides are known as the “ambassadors” of the court and are available to community members attempting to navigate the juvenile court system. Guides are usually the first point of contact for the public who come to court with questions regarding juvenile guardianship, emancipations, and dependencies. Juvenile court guides are also available to review documents and to ensure that the public understands court process.



### Improving Safety through Apprehension of drug-related offenders

The adult probation department secured stimulus funding to save five surveillance officer jobs and to combat narcotics-related crime by apprehending individuals with drug-related probation warrants. The five officers collaborated with local law enforcement and exceeded project goals. Over 1,900 probationers with drug-related warrants were apprehended in less than two years.

### A Court's Remarkable Recovery from a Capital Case Crisis

Three Superior Court Judicial Officers, Judge Robert Gottsfeld, Judge Douglas Rayes and Commissioner Patricia Starr, co-authored a story that will soon be published in the State Bar's Arizona Attorney Magazine.

The full article is expected to run in the November issue of the Arizona Attorney magazine.

Below is an excerpt from the story:

*Faced with the daunting task of managing more than twice the number of active capital cases than the Maricopa County Superior Court had traditionally experienced, the court designed a capital case management system and dedicated considerable resources. Once the Court's redesigned capital case management system was up and running the Court became increasingly efficient at processing and trying capital cases. The record number of capital cases that have been resolved the past three years (148), is one indication of the Court's capital case efficiency. The court's strict trial continuance policy, consistent with the criminal rules, cut delays significantly. The challenge for the Court in the future will be to maintain consistency, avoid unnecessary delays, and continue to ensure a fair process for all parties.*

### New Judge Appointed

Prior to her appointment, Judge Bailey served as a Commissioner in the criminal court division. Before joining the Court, she spent five years with the Civil and Criminal Divisions at the Maricopa County Attorney's Office. Her state government employment includes service as the Arizona State Senate's Rules Attorney and Judiciary Committee Analyst. She also worked at Kimerer & Derrick, PC; Fromm, Smith & Gadow; Bailey Law Offices, PLC and the Grant County Prosecutor's Office in Marion, Indiana. She graduated from Arizona State University in 1988, completing her law degree from ASU in 1992.

She fills the vacancy created by the retirement of Judge Gary Donahoe.
