ADMINISTRATIVE ORDER
NO. 2017-079

WHEREAS, pursuant to Article VI of the Arizona Constitution, the Arizona Supreme Court (“Supreme Court”) exercises administrative supervision over all courts of the state through the Administrative Office of the Courts.

WHEREAS, the Supreme Court became aware that the Town of Guadalupe was without a presiding judge.

WHEREAS, on October 31, 2016, the Supreme Court issued Administrative Order No. 2016-102 appointing the Honorable Janet Barton, Presiding Judge of the Superior Court, with administrative control and oversight of day-to-day operations and authority to assign judges pro tempore and other judges as needed to conduct court business.

WHEREAS, the Presiding Judge of the Guadalupe Town Court is authorized to appoint such judges pro tempore as are required by the Court pursuant to Article 3-1, Section 3-1 of the Guadalupe Town Code.

WHEREAS, the appointment of a judge pro tempore is necessary to ensure participation in the Glendale Municipal Court Veterans Stand Up event on September 23, 2017.

WHEREAS, the Court having found that Elizabeth Finn meets all requirements set forth in section 5-2-2 of Chapter 5, Guadalupe Town Code, and good cause appearing,

IT IS HEREBY ORDERED appointing Elizabeth Finn as judge pro tempore of the Guadalupe Town Court for the sole purpose of hearing and deciding Guadalupe Town

cases that appear at the Glendale Municipal Court, Stand Up for Veterans event, September 23, 2017.
