WHEREAS, the Arizona Supreme Court issued Administrative Order 2016-102, placing administrative authority for the Guadalupe Municipal Court with the Honorable Janet Barton, Presiding Judge of Superior Court in Maricopa County until a successor assumed duties as presiding magistrate for the Town of Guadalupe Municipal Court.

WHEREAS, the Superior Court of Arizona in Maricopa County issued Administrative Order 2016-096 appointing Karen Westover with Court Administration for the Superior Court in Maricopa County to act as a liaison with the Guadalupe Municipal Court and conduct any administrative business necessary, reporting directly to the Judicial Branch Administrator and the Presiding Judge of the Superior Court in Maricopa County until a successor assumed duties as presiding magistrate for the Town of Guadalupe Municipal Court.

WHEREAS, the Superior Court of Arizona in Maricopa County appointed Margarita Silva as a Judge Pro Tem for Guadalupe Municipal Court until a successor assumed the duties as presiding magistrate for the Town of Guadalupe Municipal Court.

WHEREAS, the Town of Guadalupe appointed Fidelis V. Garcia as Presiding Municipal Court Judge with an official start date of July 18, 2017.

WHEREAS, the Arizona Supreme Court issued Administrative Order 2017-98 rescinding Administrative Order 2016-102 and releasing Presiding Judge Janet Barton of administrative oversight of the Guadalupe Municipal Court.

THEREFORE, IT IS ORDERED rescinding Superior Court Administrative Order 2016-096.
