WHEREAS, A.R.S. § 12-213 authorizes the Presiding Judge of the Superior Court to appoint court commissioners to serve at the pleasure of the Presiding Judge; and

WHEREAS, the attorney Judith Morse is designated as Judges Pro Tempore of this Court pursuant to Administrative Orders No. 2017-053.

IT IS ORDERED that attorney Judith Morse is hereby appointed as on-call and part-time commissioner of the Superior Court in Maricopa County for the period of August 28, 2017 through June 30, 2018:

IT IS FURTHER ORDERED that attorney Judith Morse is on-call and part-time commissioner shall have all such powers and duties pursuant to law which shall include, but not limited to, those powers and duties prescribed by A.R.S. § 12-213, as amended, and Rule 96, Rules of the Arizona Supreme Court, as amended.

IT IS FURTHER ORDERED that attorney Judith Morse is on-call and part-time commissioner shall receive compensation for services rendered, if funds are available, at the rate of \$44.18 per hour. This appointment is based upon services of less than a full time basis and the annual compensation shall not exceed \$91,894.40 total. The on-call and part-time commissioner may agree in advance to donate any or all services to this Court.

IT IS FURTHER ORDERED that this appointment is conditioned upon the agreement to serve only for the compensation stated above while employed as an on-call and part-time commissioner by the Court, and to receive no additional compensation or benefit, fiscal or otherwise, when acting in the capacity of a judge pro tempore.

IT IS FURTHER ORDERED removing attorney Steve Smith as an on-call and part-time commissioner judge pro tempore, who was designated as Judges Pro Tempore of this Court pursuant to Administrative Orders No. 2017-053 and 2017-057.
