ADMINISTRATIVE ORDER
No. 2020-086

(Replacing Administrative Order
No. 2018-085)

WHEREAS, Administrative Order No. 2018-085 established administrative boundaries in Civil cases for the Phoenix Downtown, Northeast, Northwest, and Southeast Judicial Districts, and

WHEREAS, the Court seeks to ensure balanced judicial workloads, thereby providing improved case flow and reduced case delay for parties, and

WHEREAS, the Court deems it necessary to further adjust the assignment of certain case types in Civil matters utilizing a method other than administrative boundaries,

IT IS ORDERED:

1. This Administrative Order replaces Administrative Order No. 2018-085.
2. The attached ZIP code listing identifies the boundaries for each judicial district for Civil cases.
3. With the exception of paragraph seven of this Order, Civil cases shall be assigned to a judicial district based upon the ZIP code in the plaintiff's address as set forth in the plaintiff's initial filing, or, if represented, based upon the ZIP code in plaintiff's counsel's address.
4. Superior Court Civil cases originating from Maricopa County, Arizona may be filed with the Clerk of Court at any Superior Court location. Thereafter, the case shall be assigned to the appropriate district on the basis of ZIP code in the address.
5. Superior Court Civil cases originating from Pinal and Pima Counties, Arizona, shall be assigned to and heard in the Southeast Judicial District.
6. Superior Court Civil cases originating from ZIP codes not identified in the attached listing shall be assigned to and heard in the Downtown Judicial District.

7. This Administrative Order applies to all cases filed and initiated on and after June 29, 2020, except certain Civil case types that are not assigned based on administrative boundaries, such as complex civil litigation, injunctions against harassment, and tax cases. Furthermore, transcript of judgment (“TJ”), excess proceeds (“EP”), name change, amended marriage license, amended birth certificate, and foreign judgment cases will be assigned to designated calendars based on the last two case numbers of the case and using the following algorithm: 00-24 will be assigned to PCC07 DT; 25-49 will be assigned to PCC05 DT; 50-74 will be assigned to NEC02 NE; and 75-99 will be assigned to SEC02 SE.
