Pursuant to Administrative Order No. 2023-080, the members of the Capital Defense Review Committee ("Committee") act under the authority of the Presiding Judge of the Superior Court in Maricopa County and are tasked with implementing the Plan for Review of Appointed Defense Counsel (the "Plan").

The Plan provides that the Committee shall be composed of the director of the Office of Public Defense Services ("OPDS"); the heads of the three adult indigent criminal defense offices, or their designees; the Presiding Criminal Judge, or a Maricopa County Superior Court Judge designated by the Presiding Criminal Judge; and at least four members of the criminal defense bar, appointed by the Presiding Criminal Judge, who do not hold a current OPDS contract or pending contract application and who are not currently employed by a Maricopa County indigent defense agency.

The Plan provides that the Committee will recommend and the Criminal Presiding Judge shall approve replacement members as necessary.

The Plan further provides that the Committee chair and vice-chair shall be appointed by the Criminal Presiding Judge from among the current Committee members.

Due to personnel changes or new designees and the expiration of members' terms, there is a need to update the committee membership.
