ADMINISTRATIVE ORDER

On September 15, 2025, the request of the Maricopa County Public Defender (MCPD) for transfer of representation in the cases detailed on the attached exhibit came before the court.

THE COURT FINDS that the request should be granted, and that representation should be transferred from the Public Defender to the Legal Advocate's Office, the Legal Defender's Office, and the Office of Public Defense Services, who does not object to this order.

IT IS THEREFORE ORDERED that the Maricopa County Public Defender is relieved from representation of the defendant in each of the cases specified in the attached exhibit, and the Maricopa County Office of Public Defense Services is hereby appointed to assign counsel to represent those defendants.
