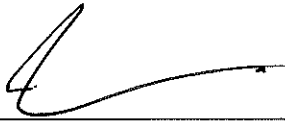

On October 20, 2025, the request of the Maricopa County Public Defender (MCPD) for transfer of representation in the cases detailed on the attached exhibit came before the court.
