IT IS ORDERED that the following retired judges are called back to active duty to serve as judges of this court as assigned by the Presiding Judge:

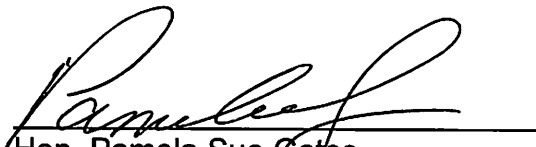
