On November 22, 2002, the Arizona Supreme Court issued Administrative Order No. 2002-107 authorizing the establishment of a Complex Civil Litigation Program on a pilot basis in the Superior Court in Maricopa County. On December 19, 2002, the Superior Court in Maricopa County issued Administrative Order No. 2002-127 establishing the Complex Civil Litigation Program on a pilot basis ending December 31, 2004.

On April 28, 2004, the Arizona Supreme Court extended the period of the Complex Civil Litigation Pilot Program to December 31, 2006 in Administrative Order No. 2004-27. On March 8, 2005, the Superior Court in Maricopa County issued Administrative Order No. 2005-038 extending the pilot program for the Complex Civil Litigation Program to December 31, 2006.

On December 20, 2006, the Arizona Supreme Court issued Administrative Order No. 2006-123 extending the period of the Complex Civil Litigation Pilot Program to December 31, 2008. On May 6, 2008, the Superior Court in Maricopa County issued Administrative Order No. 2008-059 extending the pilot program for the Complex Civil Litigation Program to December 31, 2008.

On January 22, 2009, the Arizona Supreme Court issued Administrative Order No. 2009-11 extending the period of the Complex Civil Litigation Pilot Program to December 31, 2009. On January 23, 2009, the Superior Court in Maricopa County issued Administrative Order No. 2009-008 extending the pilot program for the Complex Civil Litigation Program to December 31, 2009.

On March 25, 2009, the Arizona Supreme Court issued Administrative Order No. 2009-30 extending the period of the Complex Civil Litigation Pilot Program to December 31, 2010.

**IT IS THEREFORE ORDERED** extending the Complex Civil Litigation Pilot Program in the Superior Court in Maricopa County to end on December 31, 2010. Administration of the pilot program shall continue to be governed by Administrative Order No. 2002-127.
