On January 13, 2020, St. David Irrigation District (“District”) filed a status report regarding its investigation of the watershed file reports that include members of the District, receive water, and will be represented by the District with respect to irrigation claims. It completed its investigation of more than three-quarters of the listed watershed file reports and identified which

1 additional contested cases should be initiated. The remaining ten watershed file reports fall  
2 within two categories: watershed file reports that include land, the owners of which desire to be  
3 incorporated into the District, and watershed file reports that require additional investigation.  
4 The District has requested additional time to complete its investigation and a status conference  
5 to be set in four months to address issues related to the identification of all watershed file reports  
6 that should be included in this contested case. For good cause shown,

8 **IT IS ORDERED** that the District shall file a status report by **May 12, 2020** which reports  
9 the status of the annexation of lands included in Watershed File Reports 112-17-DBA-070, 112-  
10 17-DCA-001, 112-17-DCA-002, 112-17-DCA-006, and 112-17-DCA-018 and the results of its  
11 investigation of Watershed File Reports 112-17-ACC-027, 112-17-ACC-107, 112-17-ACD-146,  
12 112-17-BAB-001, and 112-17-BAB-002. A status conference shall be held on **May 19, 2020** at
