2:00 p.m. This is the time set for a telephonic status conference regarding potential water rights described in Watershed File Report 112-17-BAD-019 for use in real property located in the SW ¼ NE ¼, section 11, T17S, R20E.

The following attorneys and parties appear telephonically: Kimberly R. Parks on behalf of Arizona Department of Water Resources; Joe P. Sparks on behalf of the San Carlos Apache Tribe and the Tonto Apache Tribe; Bradley Pew on behalf of ASARCO; John Burnside on behalf of BHP Copper; Mark McGinnis on behalf of Salt River Project; Jay Tomkus on behalf of the Pascua Yaqui Tribe and the Yavapai-Apache Nation and landowner, Perla McGoffin, appearing on her own behalf.

A record of the proceedings is made digitally in lieu of a court reporter.

The purpose of today's hearing is to determine which landowners will assert water rights with respect to their land.

Ms. McGoffin states that she received notice of this hearing and is seeking more information on the matter regarding water rights. The Court explains the content of the Watershed File Report in this case.

Ms. McGoffin requests additional time to file a statement of claimant with the Arizona Department of Water Resources. Ms. Parks informs Ms. McGoffin on how to obtain a statement of claimant form from the Arizona Department of Water Resources.

2:06 p.m. David A. Brown appears on behalf of St. David Irrigation District.

Counsel have no objection to the dismissal of all claims, with the exception of the claim that may be brought by Sean and Perla McGoffin.

IT IS ORDERED dismissing claims to divert water for beneficial use on the land described in Watershed File Report 112-17-BAD-019 from the Pomerene Canal and the three wells identified in that Report with the exception of the land owned by Sean and Perla McGoffin.

IT IS FURTHER ORDERED that by **February 11, 2019**, the McGoffins shall file a Statement of Claimant with Arizona Department of Water Resources.

If the McGoffins do not file a Statement of Claimant by February 11, 2019, the claim will be dismissed.
