This case was initiated by Order dated December 4, 2019 to resolve objections to a potential water right identified in Watershed File Report No. 112-17-BAD-019 for irrigation use on land located in the SWNE Section 11 Township 17S Range 20E. Notice of the initiation of the case was given to the Claimant at the address of record with the Arizona Department of Water Resources and to the current landowners at addresses on file with the Cochise County Assessor.

1 None of the current landowners had filed a statement of claimant with the Arizona Department of
2 Water Resources.

3 A status conference was held on January 10, 2019, to determine if the Claimant or the
4 current landowners had an interest in pursuing the claim for a water right for the land included in
5 the watershed file report. Ms. Perla McGoffin appeared at the status conference and expressed
6 an interest in considering the filing of a statement of claimant. Ms. McGoffin was given until
7 February 11, 2019 to make a decision about pursuing a claim for a water right and filing a
8 statement of claimant with the Arizona Department of Water Resources. Neither the Claimant
9 nor any other landowner appeared at the status conference.

11 No statement of claimant appears in the public records of the Department of Water
12 Resources filed by Perla S. McGoffin or Sean and Perla McGoffin. No notice of filing a
13 statement of claimant was filed with the Court. According,

15 **IT IS ORDERED** that Sean and Perla McGoffin are dismissed from this case along with
16 claims for a water right for irrigation use as set forth in Watershed File Report 112-17-BAD-019
17 for tax parcel no. 12325002H.

18 **IT IS FURTHER ORDERED** that no further action will be taken with respect to
19 potential water rights in or objections to Watershed File Report 112-17-BAD-019 because the
20 Claimant has not appeared in this case, no current landowner other than Ms. McGoffin has
21 appeared in this case indicating an interest in asserting a water right, and no current landowner
22 has filed a statement of claimant or obtained an assignment of the existing statement of claimant.
