David Brown advises the Court that he represents the St. David Irrigation District and that landowners Beverly and Thomas Wing, Gail and Renita Larson, and Jacob and Jennifer Kartchner have joined the St. David irrigation District. He further advises that the potential water rights at issue should be address in *In re St. David Irrigation District*.

IT IS ORDERED that this contested case and the potential water rights, analyzed in WFR 112-17-BAD-021 applicable to land owned by Beverly and Thomas Wing and

Gail and Renita Larson, are consolidated with *In re St. David Irrigation*, contested case no. W1-11-1675.
