William Gordon filed Statement of Claimant 39-4094 for irrigation and domestic use. The public records of Arizona Department of Water Resources do not contain any assignments 

of the Statement of Claimant. Mr. Gordon identified the source of water as a well which he avows as having been in operation prior to 1920.

The Arizona Department of Water Resources included the well as a Catalogued Well and referred to 112-17-DBA-320 as the data source in the Final San Pedro River Watershed Hydrographic Survey Report (1991). A copy of the Catalogued Well reference is attached as Attachment A and a copy of the map of 112-17-DBA-320, which is labelled as "(320)" is attached as Attachment B.

In a Status Report filed by St. David Irrigation District ("District") dated January 13, 2020, the District stated that it has determined that the landowners in this case are members of the District, receive water and will be represented by the District. According to the District, the property involved is tax parcel number 121-11-006 with Dale Ireson and Thomas A. Ireson as the named owners. A copy of the Cochise County Assessor's map of the tax parcel is attached as Attachment C. Accordingly,

#### IT IS ORDERED:

- Contested Case, Consolidation, Designation and Docket Number. This Order initiates contested case no. W1-11-2117. This contested case is consolidated with *In re St. David Irrigation District*, Contested Case No. W1-11-1675.
- 2. <u>Litigants</u>. The litigants in this contested case are the claimant, the landowner, the District and all persons who filed objections to the watershed file report who are listed on Attachment D, and claimants who are allowed to intervene by order.
- 3. <u>Court-Approved Mailing List</u>. The initial Court-approved mailing list for this case shall include all persons listed on Attachment D to this Order. The mailing list shall be merged with the mailing list for *In re St. David Irrigation District*.

4. Consent. The St. David Irrigation District shall file a consent in this contested case with copies mailed to those individuals listed on Attachment D by February 28, 2020 signed by the landowners listed above who consent to be represented by St. David Irrigation District in In re St. David Irrigation District.


