1 On May 28, 2020, the Town of Mammoth filed a Status Report stating that a stipulated
2 agreement had been reached with all of the Objectors except the Tonto Apache Tribe, the San
3 Carlos Apache Tribe, the Yavapai Apache Nation, and the United States and requested an
4 additional ninety days to attempt to obtain formal agreement from all objectors to abstracts for
5 proposed water rights.


6 IT IS ORDERED that the Town of Mammoth shall file by **September 4, 2020** stipulated
7 abstracts for proposed water rights. If the parties cannot reach an agreement to resolve their
8 objections, the parties shall file Rule 26.1 Disclosure Statements on **September 18, 2020** and
