

On October 30, 2020, Salt River Project Agricultural Improvement and Power District and Salt River Valley Water Users' Association filed suggested corrections to the proposed abstracts prepared for the *de minimis* potential water rights identified in Watershed File Report No. 113-09-019 ("WFR"). On October 30, 2020, the Arizona State Land Department also filed suggested corrections and comments to the proposed abstracts in the WFR. No other suggested corrections were received.

1 On July 6, 2020, Arizona Department of Water Resources ("ADWR") had filed a Report
2 to which it attached preliminary maps of the locations of the places of use and points of diversion
3 for potential water rights identified in the WFR. With respect to a number of the potential water
4 rights, ADWR commented, "the location needs to be clarified". The landowner has now
5 submitted its proposed corrections to the draft abstracts that include corrections to the places of
6 use and points of diversion.

8 **IT IS ORDERED** that Arizona Department of Water Resources shall prepare and file
9 maps showing the places of use and points of diversion for each of the 24 proposed water rights
10 consistent with the attached abstracts by **January 11, 2021**.
