According to the public records of Pima County Assessor, Ronnie L. Hilliard, as trustee, owns the land that is the subject of the water claims investigated by Arizona Department of Water Resources. On July 27, 2020, an Order was issued setting a Status Conference in this

1 case. Among others, a copy of the Order was sent to the last known address for Clarence and
2 Carol Moyers. The Order was returned with no forwarding address. On September 25, 2020,
3 the Status Conference was held to determine if the Claimants or the current landowner intend to
4 pursue water rights for the land.


5 Neither the Claimants nor Ronnie L. Hilliard, as trustee, appeared at the Status


17 Failure to appear by shall result in the dismissal of Statements of Claimant and
