DESCRIPTIVE SUMMARY: The dates set for completion of discovery, file dispositive motions and begin trial on October 21, 2019 are vacated. The parties shall file a joint settlement report by **August 26, 2019**. Responses to Pima County Flood Control District's *Motion to Vacate Order and to Amend Abstract for Proposed Water Right 113-12-021-SW002* due by **August 7, 2019**.


1 On July 19, 2019, the District filed a motion to amend the proposed abstract for water
2 right 113-12-021-SW002.

3 In addition, on July 22, 2019, the parties submitted a joint settlement report that resolved
4 two claims for potential water rights and indicated that discussions are continuing with respect
5 to claims for potential water rights 113-12-BA-013-IR001 and 113-12-BA-013-IR002. Pima
6 County Flood Control District ("District") proposed submitting a second joint settlement report
7 by August 26, 2019 if settlement of all objections cannot be reached with respect to the
8 potential water rights.
9

10 **IT IS ORDERED** that the parties shall file a joint settlement report by **August 26, 2019** if
11 they cannot agree on mutually-acceptable proposed abstracts for 113-12-BA-013-IR001 and 113-
12 12-BA-013-IR002.

14 **IT IS FURTHER ORDERED** that due to the settlements accomplished and continuing
15 settlement discussions, the dates set for completion of discovery, file dispositive motions, and
16 begin trial by prior court orders are vacated.

17 **IT IS FURTHER ORDERED** that responses by any party or any objection by Arizona
18 Department of Water Resources to the District's proposed amendment to the proposed abstract for
19 113-12-021-SW002 shall be filed by **August 9, 2019**.
