The Salt River Project Agricultural Improvement and Power District and Salt River Valley Water Users' Association (collectively, "SRP") having filed a Second Status Report and Motion for Additional Time on June 28, 2019 and good cause appearing therefor, IT IS HEREBY ORDERED that SRP shall file by July 29, 2019 a signed settlement stipulation with regard to all objections. ~~If the case has not settled at that time, SRP shall file an updated status report on that date.~~

1 IT IS FURTHER ORDERED that if a signed settlement stipulation is not filed by July
2 29, 2019, the Objectors who have not agreed to the proposed settlement shall file by August 1,
3 2019, a status report along with a proposed schedule to have the matter resolved by the Court.
4 Objectors who have expressed an intent to execute the settlement stipulation referenced in the
5 Second Status Report filed by SRP on June 28, 2019 shall have no obligation to file a status
6 report and no action is required by those Objectors to preserve the continued validity of
7 previously filed objections in the absence of a signed and filed settlement stipulation.


8 IT IS FURTHER ORDERED that in the absence of a signed settlement stipulation filed
