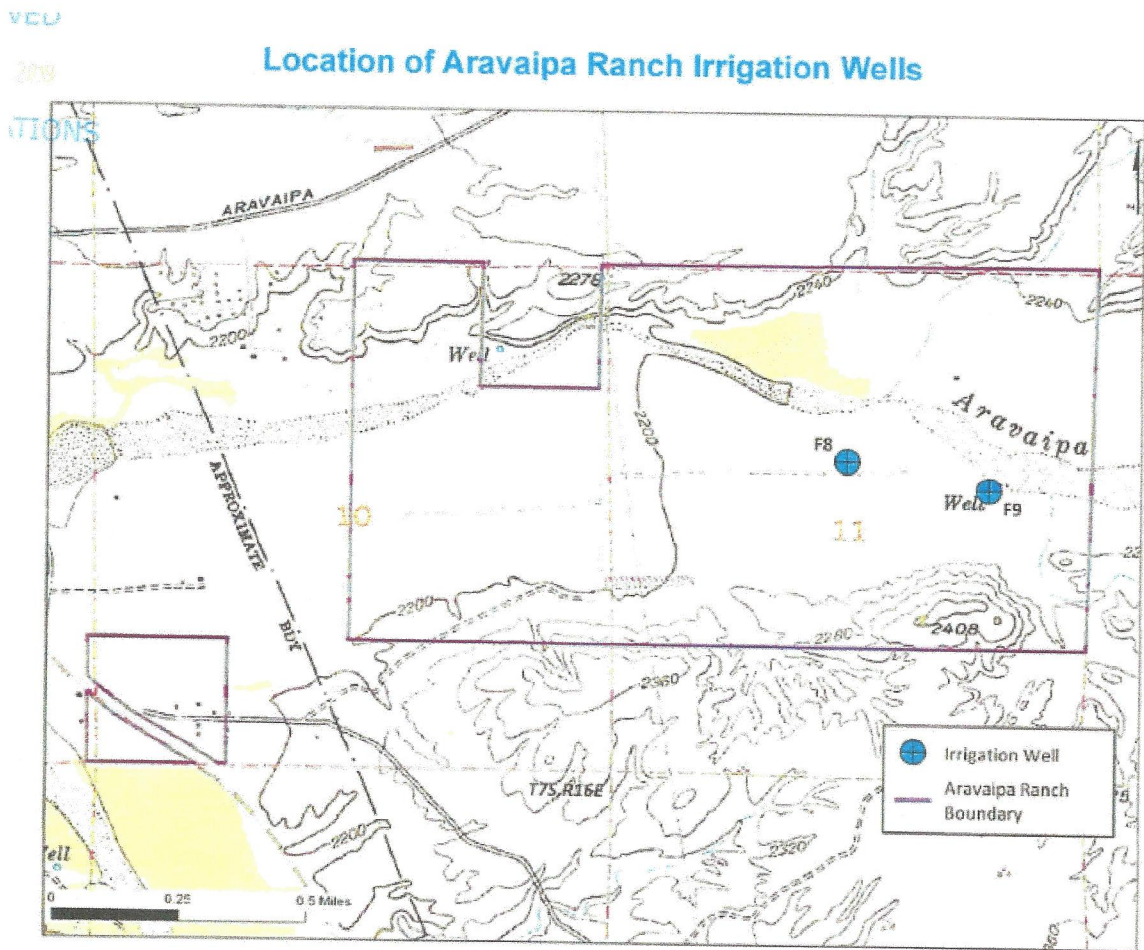

CONTESTED CASE NAME: *In re BLM - SRP*
HSR INVOLVED: San Pedro River Watershed Hydrographic Survey Report
DESCRIPTIVE SUMMARY: No claims exist for rights to use water on land included within the boundaries of Watershed File Report 114-04-BDD-032. Accordingly, this contested case is dismissed.

On February 4, 2020, the United States and the Salt River Project Agricultural Improvement and Power District and Salt River Valley Water User’s Association (“Salt River Project”) filed a Status Report regarding water uses on land included within the boundaries of Watershed File Report 114-04-BDD-032. The Bureau of Land Management stated that it does not intend to assert a claim for water rights on the subject property. Salt River Project stated

1 that it does not intend to assert claims for water rights on the subject property pursuant to
2 Statements of Claimant 39-1976 or 39-1977.

3 The remaining Statement of Claimant, 39-2482, was filed by ASARCO Incorporated and
4 amended by ASARCO LLC in 2019. It included a map of the land subject to its claim:

23 The map does not include the southeast quarter of the southwest quarter of section 10
24 T7S16E. In its objection to WFR 114-04-BDD-032, ASARCO Incorporated stated the property
25 that was the subject of Statement of Claimant 39-2482 was properly the subject of Watershed
26 File Report 114-04-BDD-002. ASARCO was given until February 4, 2020 to amend its
27 Objection if it intended to claim a water right to the land that is the subject of WFR 114-04-
28 BDD-032.


No amendment having been filed and, based on the Status Report, no claim is made for a right to use water on the land included within the boundaries of Watershed File Report 114-04-BDD-032,
