IT IS ORDERED

- 1. Arizona Department of Water Resources (ADWR) shall file a Report by December 20, 2019, providing its comments on the basis of right, place of use, point of diversion, the attached map, and the GPS coordinates for the point of diversion set forth in the Proposed Abstracts provided by Claimants on November 8, 2019. The Report shall also state ADWR's position regarding the consolidation of the two proposed abstracts into a single abstract for domestic use and identifying the proposed quantity of water consistent with the findings in the WFR.
- 2. Claimant shall either distribute to all parties proposed abstract(s) consistent with ADWR's Report or file an Objection with the Court by January 10, 2020.
- 3. If Claimant distributes proposed abstract(s) to the parties, then the parties shall either sign a Stipulation, Withdrawal of Objections, and Request that the Special Master Approve Proposed Water Right Abstracts for Julia Pemberton ("Stipulation") along with a proposed order by January 21, 2020 or file a Notice of Objection to the Stipulation by that same date. Upon receipt of a Notice of Objection, a Scheduling Conference shall be set. If no Notices of Objection are filed, Claimant shall file the Stipulation by January 24, 2020.
