Arizona Department of Water Resources submitted a Meeting Report stating that the parties and Objectors had met in this case on July 9, 2019. This case involves potential water rights for domestic use (potential water right 115-05-AB-002-DM001) and an irrigation use associated with a domestic use (potential water right 115-05-AB-002-OT001). Arthur Pacheco, Anna Pacheco, Alex Pacheco, Christine Pacheco, and David Pacheco (the Pacheco


1 Family) represented that they would prepare proposed abstracts and provide them to the parties
2 and ADWR within 90 days. The proposed abstracts should be mailed to all of the parties
3 listed in Attachment A by **October 7, 2019**.

4 **IT IS ORDERED** that ADWR shall review the proposed abstracts and file a Report by
5 **October 24, 2019**. If a map showing the proposed places of use for the potential water rights is
6 not attached to the proposed abstracts, ADWR shall provide to Claimants a map of the parcel
7 of land on which the potential water rights will be exercised that labels the section, township
8 and range. Claimants will submit a map that shows the boundaries of the irrigated lands by
9 providing GPS coordinates for corners of the irrigated areas.

10 **IT IS FURTHER ORDERED** that if The Nature Conservancy or the Gila River Indian
11 Community has any objection to the information or lack of information included in the
12 proposed abstracts, counsel for the objecting entity shall contact a member of the Pacheco
13 Family to discuss its objection to the proposed abstract no later than **October 25, 2019**.

14 **IT IS FURTHER ORDERED** that a status conference shall be held on **November 1,**
15 **2019**, at 2:50 p.m. in the Superior Court of Arizona, 201 West Jefferson Street, Courtroom 301,
16 Phoenix, AZ 85003-2202. Objectors shall be prepared to address the substance of the
17 proposed abstracts at the status conference.
