Arizona Department of Water Resources submitted a Meeting Report stating that the parties and Objectors had met in this case on July 9, 2019. At the meeting, counsel for Sandra Fraser, Daniel and Cindy Tapia, and Norma Luepke represented that within 90 days he would prepare and circulate amended Statements of Claimant, Statements of Claim, draft abstracts and maps.

1 **IT IS ORDERED** that by **October 7, 2019**, Claimants shall file amended Statements
2 of Claim and Statements of Claimant with Arizona Department of Water Resources (ADWR)
3 and shall circulate proposed abstracts and maps to all parties and to ADWR.

4 **IT IS FURTHER ORDERED** that ADWR shall review the proposed abstracts and
5 maps and file a Report by **October 24, 2019**.

6 **IT IS FURTHER ORDERED** that a status conference shall be held on **November 1,**
7 **2019**, at 2:40 p.m. in the Superior Court of Arizona, 201 West Jefferson Street, Courtroom 301,
8 Phoenix, AZ 85003-2202. Objectors shall be prepared to address the substance of the proposed
9 abstracts at the status conference.
