Court reporter, Lori Thielmann, is present and a record of these proceedings is made digitally.

Ms. Consoli states that she has been running two parallel processes: 1) one to resolve this case; and 2) seek approval of a case information report with all the parties. She further states that the case information report has been filed with the Court and it does not contain a schedule or dates for trial.

Ms. Consoli states that the parties are so close to a resolution that she did not include dates for court proceedings. Ms. Consoli has circulated a draft stipulation with proposed abstracts. She has heard from all of the parties in this case. Ms. Consoli further states that she needs to distribute revised documents to the parties. It is her intention to distribute those documents within ten to fifteen days.

The Court will not set a discovery and trial schedule at this time based on TNC's representation.

Mr. Sparks requests thirty days to review the documents once he receives them.

Mr. McGinnis, Mr. Cahoy, Mr. Burnside, and Ms. Montgomery have already completed their review.

Mr. Pew states that he only needs a little bit of time to review the changes.

The Court inquires if TNC has resolved all of their cases.

Ms. Consoli states that they have one more case, *In re: Geldmacher*. She stated that she did not receive notice of the hearing that was held on July 18, 2019 in that matter. TNC owns property and they have certificated in-stream flow right and will be participating in that case.
