The Court addresses Ms. Magoffin. Discussion is held to determine whether Ms. Magoffin has filed a current Statement of Claimant (SOC), and whether she intends to pursue the water claims that ADWR found in this matter. Ms. Magoffin states that she filed a SOC in July 2019.

The Court states that the court order sent in this matter to the last known address for Robert L. Kramme and the estate of Karen LeCount have been returned by the United States Post Office with no known forwarding address.

IT IS ORDERED the Court shall remove the names of Robert L. Kramme and Karen LeCount from the court-approved mailing list for this case.

The Court notes that there are two SOCs that are not assigned and there is a new SOC that a land owner intends to use.

Mr. McGinnis addresses the Court and discussion is held regarding the fact that in the past ADWR has conducted meetings with the land owner who intends to pursue his/her water rights and any objectors for the water rights.

Ms. Magoffin states that she is amenable to participation in this meeting. Kimberly Parks states that she can conduct a meeting within the next 30 days.

Ms. Magoffin states that Ms. Le Count and Mr. Cramme are deceased.

IT IS ORDERED that all SOCs that originated and were filed prior to 1991 and upon which she is relying for water rights must be compiled in a list by Ms. Magoffin prior to her meeting with Kimberly Parks of ADWR and filed with the Clerk of the Court with copies to parties on the Court-approved mailing list.
