2020, Bar Seven Cattle Company LLC moved for an extension of time to submit proposed abstracts for water rights in this contested case on the grounds that it has not yet received a new grazing lease from the Arizona State Land Department for the land included within the boundaries of the WFR.

IT IS ORDERED granting the Motion for Extension of Time and directing the Arizona State Land Department to prepare and file with Arizona Department of Water Resources proposed abstracts for the two *de minimis* water rights identified WFR 115-06-004 by September 8, 2020. The Arizona Department of Water Resources shall review the proposed abstracts regarding the location of the points of diversion and places of use and file its report by October 23, 2020. If Bar Seven Cattle Company LLC intends to make a claim for additional *de minimis* water rights on the land included in WFR 115-06-004, it shall file copies of its Statements of Claimant and proposed abstracts with the court by September 8, 2020.
