Mr. Brown updates the Court on the amendments made to Brighthawk, LLC's Amended Statements of Claimant (SOC). Copies of the same were mailed to all objecting counsel with proposed abstracts that reflected all of the SOC and included an irrigation use, domestic use, and stock water use. A Stipulation and Order has been delivered to all objectors and responses have been received by all objecting parties except Mr. Sparks, Mr. Murphy and Mr. Barry. Mr. Brown will also provide a copy to Mr. Leininger.

Mr. Barry reports that he and Mr. Sparks have requested additional time to review the abstracts and stipulation.

Mr. Sparks expresses his concern regarding the need for a definitive legal description of the land to which the water right is appurtenant.

Mr. McGinnis and Ms. Interpreter agree with Mr. Spark's position with respect to the legal description of land relating to the water rights issue. Mr. McGinnis suggests aerial photographs in lieu of surveys if possible.

The Court will attach a copy of the map produced by ADWR which was part of its HSR to this minute entry which may suffice to resolve the parties' concerns about an accurate description of the boundaries of the appurtenant land.


IT IS ORDERED ADWR will provide any aerial photographs it has showing the Brighthawk irrigation area to the parties by March 19, 2018.

IT IS ORDERED the Stipulation and proposed abstracts shall be filed on or before April 3, 2018, or, whoever objects to it, shall file an objection specifically identifying those items in the draft Stipulation which are not acceptable. Any objection to the watershed file report previously raised will not be waived by the filing of the objection to the Stipulation.
