10:00 a.m. This is the time set for a Status Conference before Special Water Master, Sherri Zendri.

The following attorneys and parties appear virtually:

- Property owner, Amber L. Perry, is present on her own behalf
- Jared Crum and Alexa Penalosa on behalf of the United States Department of Justice
- Katya Lancero on behalf of the Navajo Nation
- Brandon Delgado on behalf of the Hopi Tribe
- Garrett Perkins observing on behalf of the LCR Coalition
- Mark McGinnis observing on behalf of Salt River Project (SRP)
- Kimberly Parks on behalf of Arizona Department of Water Resources (ADWR)

A record of the proceedings is made digitally in lieu of a court reporter.

The Court presents a summary of the case. The Court inquires if Ms. Perry has registered the stockpond in question?

Ms. Perry affirms.

The Court inquires of ADWR if the registration has been processed and, if so, what the registration number is?

Ms. Parks states that she did not assist with this process and Ms. Perry might have the number.

Ms. Perry will look for the registration number.

The Court states that the objection filed by the U.S. is regarding a well. The Court inquires if there a well on property?

Ms. Perry states that there is a well and she has amended the SOC to include the well, a spring, and the registration of the stockpond.

The Court inquires if all of the named water sources have been registered?

Ms. Perry affirms. The stockpond registration number is 3896834.000. The amended SOC number is 39-80599. The well registration number is 545760.

The Court states that ADWR will need to provide the Court with a revised WFR. The revised Statement of Claimant appears to include all appropriate pre-adjudication documents. The Court inquires if Ms. Perry remembers the amount of water claimed on the SOC?

Ms. Perry states that 2 acre/feet are claimed.

The Court will double check that all amounts claimed are below the *diminimus* use guidelines. The Court states that ADWR will need to create a draft abstract. The Court inquires if 30 days is enough for ADWR to provide the revised WFR and draft abstract?

Ms. Parks would like 90 days.

IT IS ORDERED that ADWR shall file the revised WFR and draft abstract no later than **January 10, 2025**.

The Court will allow comments on the new documents at the next hearing, but no written comments are required. To discuss the status of the case and hear comments,

IT IS FURTHER ORDERED setting a further Status Conference on **February 12, 2025, at 10:00 a.m.** The status conference will be held using the Court Connect program. Instructions for Court Connect are attached as Attachment A. If you receive this
