17 landowners to appear.

19 This contested case was initiated December 7, 2023, and the initial status
20 conference was held on February 8, 2024. Current property owner, Donna Williams,
21 initially expressed interest in pursuing water rights claims for Navajo County tax parcel
22 208-03-004C. However, Ms. Williams failed to attend the status conference scheduled
23 for April 24, 2025, and Ms. Williams did not respond to the Court's order to show cause
24 as required in the minute entry filed May 1, 2025. Furthermore, Ms. Williams did not
25 submit to the Arizona Department of Water Resources any of the information required
26 pursuant to the Special Master's February 18, 2025, Order.


