The Court inquires if the parties have updated their Statement of Claimants ("SOCs") and the basis of rights documents.

Mr. Speakman affirms that he has updated his SOCs but was unable to provide basis of right. He spoke with the surface water section and they indicated that he did not need to provide a basis of right.

Counsel Nielsen addresses the Court. She reports that she received an email from Mr. Speakman. She has forwarded the email to the surface water section team and they will reach out to him shortly.

Mr. Shumway believes he has done what is required of him. He states that he has updated both Statement of Claim and Statement of Claimant with the basis of right form.

Counsel Nielsen affirms that she received a packet from the Shumways and the surface water section has received the updated 36 filings. It has not been processed yet.

The Court provides context regarding confusion about the basis of right requirements.

Mr. Speakman indicates that his basis of right form will likely be similar to Mr. Shumway's.

IT IS ORDERED that Mr. Speakman complete his filings by March 31, 2025.

IT IS FURTHER ORDERED that ADWR file a Status Report providing an update regarding the processing of the filings by June 6, 2025. The Court will inform the parties of the next steps by separate order once the Status Report is received.

No objections are stated to the Court's proposal.
