

On May 29, 2025, the Arizona Department of Water Resources (“ADWR”) timely filed a status report providing an update on the processing of filings in this contested case. Processing of a new Statement of Claim of Right filing, and an assignment request for Statement of Claim of Right No. 36-37876 had not been completed, and the agency stated it was currently backlogged by approximately 100 filings and may take several months for the submissions in this contested case to be fully processed.

IT IS ORDERED that ADWR shall provide a status update when the filings have been processed or by **December 1, 2025**, whichever comes sooner. If the filings have still

1 not been processed by December 1, 2025, ADWR will provide a deadline when
2 processing will be complete.
