10:01 a.m. This is the time set for Status Conference to receive an update from Counsel Snow, discuss any remaining objections, and obtain an update from the Reidheads before Special Water Master Sherri Zendri.

The Water Master notes that Trenton C. and Amber Reidhead have failed to appear for today's Status Conference. Pursuant to the Minute Entry dated May 27, 2025,

**IT IS ORDERED** removing Trenton C. and Amber Reidhead from the Courtapproved mailing list and dismissing any potential water right claims they may have associated with watershed file report 33-51-008.

Discussion is held regarding how to proceed. Counsel Snow informs the Water Master that he has reached out to ADWR and their staff will be working with them to address the missing information. He further advises that there are some minimal mapping issues on the report such as tank locations that will need to be fixed and there are some claims filed by older entities that will need to be updated to reflect the correct ownership titles. Counsel Snow is in agreement with 60 days to work through the missing information and title updates.

IT IS FURTHER ORDERED that Counsel Snow shall file a Status Report on or before Wednesday, November 12, 2025, giving notice that all documentation has been completed and/or submitted to ADWR, and indicating whether there are any applications to be processed by ADWR.

Counsel Nielsen provides an update to the Water Master. She indicates that ADWR has certifications to complete on some of the stockpond registration filings. She notes that the name issues on the SOCS may need to be done by assignment or amendment.

IT IS FURTHER ORDERED that ADWR provide a Status Report on or before Wednesday, November 12, 2025, informing the Water Master of the agency's anticipated schedule to complete stockpond certifications for this contested case.
