16 DESCRIPTIVE SUMMARY: This order grants an extension to the Church of Jesus
17 Christ of Latter-Day Saints to update title to lands and water claims by **February 6, 2026**.


19 On November 7, 2025, the Church of Jesus Christ of Latter-Day Saints
20 (“CJCLDS”) and the Arizona Department of Water Resources (“ADWR”) filed a joint
21 status report regarding the CJCLDS’s progress updating the adjudication documents for
22 this contested case. The CJCLDS requested an additional 90 days to complete the
23 necessary documentation.

24 **IT IS ORDERED** granting an extension to the CJCLDS to **February 6, 2026**, to
25 complete the updates to the title to lands and water claims.

26 **IT IS FURTHER ORDERED** that CJCLDS and ADWR shall file a joint status
27 report no later than **February 6, 2025**, giving notice that all documentation has been
28 completed and/or submitted to ADWR, and providing an estimated schedule for ADWR

1 to complete processing of all documents for this contested case.
