ORDER DISMISSING CASE

DESCRIPTIVE SUMMARY: This order dismisses case CV6417-33-5704.

This contested case was initiated on July 19, 2024, to adjudicate potential water rights investigated in watershed file report ("WFR") 33-51-023. This WFR investigated an area of the San Pedro River watershed that had been subdivided after the publication of the San Pedro Hydrographic Survey Report. At the time of the WFR investigation, a small stockpond was located on land currently identified as Cochise County Parcel #404-95-055, which is currently owned by Timothy Jeffries. None of the landowners of the other parcels identified as part of the land included in the WFR investigation appeared to be using appropriable water and were dismissed from this contested case by order on November 20, 2024.

Mr. Jefferies did not attend the initial status conference scheduled for September

19, 2024. Therefore, also in the November 20, 2024, order, Mr. Jeffries was instructed to inform the Special Master by January 31, 2025, if he intended to pursue any potential water rights associated with his parcel. As of the date of this order, the nothing has been received from Mr. Jefferies.

IT IS ORDERED dismissing contested case CV6417-33-5704 and any potential water rights associated with statement of claimant #39-84810 for failure to participate.
