
18 This contested case was initiated on July 19, 2024, to adjudicate potential water
19 rights investigated in watershed file report ("WFR") 33-51-023. This WFR investigated
20 an area of the San Pedro River watershed that had been subdivided after the publication
21 of the San Pedro Hydrographic Survey Report. At the time of the WFR investigation, a
22 small stockpond was located on land currently identified as Cochise County Parcel
23 #404-95-055, which is currently owned by Timothy Jeffries. None of the landowners of
24 the other parcels identified as part of the land included in the WFR investigation
25 appeared to be using appropriable water and were dismissed from this contested case by
26 order on November 20, 2024.

27 Mr. Jefferies did not attend the initial status conference scheduled for September
28


1 19, 2024. Therefore, also in the November 20, 2024, order, Mr. Jeffries was instructed
2 to inform the Special Master by January 31, 2025, if he intended to pursue any potential
3 water rights associated with his parcel. As of the date of this order, the nothing has
4 been received from Mr. Jefferies.

5 **IT IS ORDERED** dismissing contested case **CV6417-33-5704** and any potential
6 water rights associated with statement of claimant **#39-84810** for failure to participate.
