Mr. Brown states that it is his recollection that Silver Creek Irrigation District filed an objection in this case.

Ms. Brennan addresses the Court and states that she has not seen objections from Silver Creek Irrigation District or from the tribes. She says that there are two claims in this case. One claim concerns a domestic well serving the residences on the property. She does not know if the well is pumping subflow, so it would be helpful if ADWR could delineate a subflow zone in this area. If the well is in the subflow zone, then the question is whether there will be a domestic *de minimis* standard. She suggests that ADWR be requested to prepare a technical report that could be used to establish a domestic *de minimis* standard.

The second claim concerns a fish hatchery that is a non-consumptive use. The ponds are gone. She states that it is possible that an in-stream flow claim may be the better claim. She would like to discuss the claim with the Arizona Game and Fish Commission. The Commission meets in December, and she believes that more than one meeting will be necessary to allow the Commission to make a decision about its claim. Meetings of the Commission will be held in December 2022, February 2023, and by March 2023 she will know the Commission's position about its Statement of Claimant.

Mr. Brown addresses the Court regarding a technical report from ADWR pertaining to domestic use. He said that report should include information regarding the wells in the subflow zone.

Mr. McGinnis addresses the Court and states he does not know the reason that domestic use was not included in the technical report evaluating *de minimis* stock pond and stockwatering use. He believes all wells, inside and outside the subflow zone, should be included in the technical report. He also advised that he believes a certificate of water right has been issued.

Ms. Hoover states that the Nation needs time to evaluate its objections. She also agrees that a subflow analysis should be done. She states that all wells should be included in a technical report dealing with domestic water use.

Mr. Londen states that the Hopi Tribe's objections are joinders with the United States. He wants to know if the United States intends to pursue those objections and then he plans to consult with his client.

Ms. Willard states that this case in on the list to discuss with the federal client agencies to determine whether to continue to pursue the objections. She would be willing to meet with the Arizona Game & Fish Commission after Ms. Brennan has a better sense whether the claims will change or remain the same.

THE COURT STATES that it will allow Ms. Brennan the requested time to conduct the two meetings and to will allow the other parties time to revisit their objections after they have more information regarding the Commission's intent to pursue the claims.
