ORDER TO FILE A STATUS REPORT

CONTESTED CASE NAME: *In re Jack G. and V. Scott Peterson*
HSR INVOLVED: Silver Creek Hydrographic Survey.
DESCRIPTIVE SUMMARY: Claimants are ordered to file a status report no later than **June 26, 2026**.

On January 14, 2026, the Arizona Department of Water Resources (“ADWR”) filed responses to questions regarding Open ET¹ posed by the Special Master in an October 7, 2025, status conference for this contested case. The questions were the result of an earlier statement by ADWR that the agency “prefers the Open ET methodology to quantify irrigation uses . . .”over the Penman-Monteith methodology.² However, despite this preference, ADWR has also indicated, that in the event irrigation quantification must be reevaluated for a contested case arising out of the 1991 San Pedro watershed



1 Hydrographic Survey Report, ADWR will use the same “quantification methodology a
2 was use at the time of the publication of the original WFR [watershed file report],”³ which
3 was the Penmen Monteith methodology. In other words, either methodology is
4 satisfactory for these contested cases, so long as the appropriate data is available.
5 However, before any irrigation quantity can be considered, there are a number of
6 threshold issues that must be resolved:

7 **IT IS ORDERED** that Jack Peterson shall file no later than **June 26, 2026**, a
8 status report that includes at a minimum:

- 9 1) Confirmation that **all final** Statements of Claimant have been filed and or
10 updated with ADWR.
- 11 2) Declaration of an appropriate legal basis for the claimed right.
