MINUTE ENTRY

11:01 a.m. This is the time set for an initial conference with the Court after a lengthy pause in adjudication, before Special Water Master, Sherri Zendri. This is a case to determine rights to use water on land that the Navajo County Assessor has identified as owned by (60) individuals and entities, and to determine if each landowner is interested in pursuing water rights claims.

In this case, the United States Forest Service ("Claimant") filed Statement of Claimant (SOC) 39-89984 in 1985, which contains a claim for a stockpond located on it. ADWR investigated the claims made by claimant and prepared Watershed File Report WFR 33-56-077 published in the Final Silver Creek Watershed Hydrographic Survey Report in 1991. Objections concerning the basis of right were then filed. The purpose of this case is to consider the claim in SOC 39-89984 and to resolve objections to WFR No. 33-56-077.

WFR 33-56-077 lists Transamerica Title Company previously owned the parcel of land that most of the landowners are living on.

Ms. Ust, on behalf of SRP, states that although SRP is listed as an objector in the case initiation order, SRP did not file any objections to the WFR under consideration. The Court acknowledges the error and agrees that SRP has not filed any objections regarding the WFR in consideration for this contested case.

Landowners, Mark Stachon, Mitchell Araman and Judith Nordberg, Trustee, Joseph and Ellen Castaldo, Sandra Hatcher, and Johanna Hamill each state that they are not interested in pursuing a water right.

Bruce and Julie Phillips, Trustees, inform the Court that they no longer own the land.

The Court will send out a separate notice to each landowner that requires any landowner who has not appeared today and is interested in pursuing water rights, to appear at the next Status Conference and come forward to inform the Court that they are going to pursue water rights.
