Adjudications.

2 In a Minute Entry filed January 9, 2025, for this contested case, the Special Master ordered Arizona State Land Department ("ASLD") to "seek certification of uncertified 3 4 post-1919 stockponds by March 1, 2025." W1-11-1511, Minute Entry at 3 (Jan. 9, 2025). 5 ASLD subsequently reminded the Court that the Court had previously approved abstracts 6 for numerous uncertified, but registered stockponds. ASLD's Notice of Filing Basis of 7 Right Amendments, Requests for Certification and Formal Request to Reactivate Claim 8 No. 38-88613 with ADWR at 3 (March 3, 2025). ASLD further stated that it has over 9 690 stockpond applications pending in the San Pedro River Watershed. Id. Further, 10 ADWR filed comments with the Court listing 173 abstracts approved for uncertified, but 11 registered stockponds. ADWR Comments at 2 (March 18, 2025).

A certification requirement for stockponds would impact numerous contested cases throughout the Little Colorado River and Gila River Basins, including cases that have already been settled or decided.

THERFORE, IT IS ORDERED designating the following as issues of broad legal
 importance:

- 17 1) At minimum, what must a claimant show to prove the existence of a18 basis of right?
 - a) May an appropriation initiated after June 12, 1919, be perfected without a water right certificate?
 - b) Is evidence of perfection of an appropriation pursuant to a permit under Arizona Revised Statutes section 45-153 or a stockpond claim under section 45-273 a sufficient basis of right?
- 24 2) If certification is necessary, how can ADWR expedite the certification
 25 process?
- 3) If certification is necessary, how best should the Court address the
 abstracts previously approved, despite the absence of a certificate?
- 28 Notice of this issue of broad legal importance is distributed to all parties on

the Court-Approved Mailing Lists ("CAMLs") for Little Colorado River and Gila 2 River Basins. Further proceedings regarding this issue will occur within contested 3 case W1-11-1511.
