Jeffrey Heilman on behalf of Salt River Project; Kimberly Parks on behalf of AZ Department of Water Resources (ADWR); Bradley Pew on behalf of ASARCO; Joe Sparks on behalf of San Carlos Apache Tribe and Tonto Apache Tribe; Steve Wene on behalf of the Hedrick-Gorman Trust; and Catherine Gorman and Phillip Hedrick on behalf of the Hedrick-Gorman Trust.

Mr. Wene advises the Court that he and Mr. Sparks have worked out the issues and a stipulated proposal will be distributed for signatures.

Two separate abstracts will be prepared; one for stock water and one for irrigation. Water Right nos. 115-ADA-001-IR001 and 115-ADA-001-IR002 will be combined into one abstract.

Discussion is held concerning the limitations for the stock water and irrigation abstracts. The amount of water for irrigation use is taken from the ADWR report.

Mr. Sparks confirms the stipulation and addressed the map provided by Mr. Wene. He states that the map provided had GPS coordinates on an irregularly shaped parcel. He requested an USGS overlay on the map to show the township and range and base and meridian reference.

There is no objection to the proposed stipulation.

Mr. Wene states that he will circulate the proposal next week to all the parties.

The Court asks Ms. Parks if ADWR can provide the overlay if Mr. Wene provides a copy of the map. Ms. Parks states that it is possible.

Mr. Wene is directed to provide Ms. Parks with a copy of the map so ADWR can add the overlay showing the section, township and range.
