**ORDER FOR PROPOSED PLAN TO  
DEVELOP ABSTRACT MAPS**

**CONTESTED CASE NAME:** Multiple – see attachment.  
**HSR INVOLVED:** San Pedro River Watershed Hydrographic Survey Report  
**DESCRIPTIVE SUMMARY:** Order for the Arizona Department of Water Resources to provide by **March 18, 2024**, a schedule for the creation of remaining maps for previously approved abstracts and an estimate of personnel hours needed for the same.  
**NUMBER OF PAGES:** 11

From March 2017 through July 2020, approximately 250 abstracts from 18 contested cases were approved without accompanying maps. *See* Attachment I. As a matter of consistency and to avoid as much confusion as possible in the event of a future enforcement issue, maps shall be added to the listed abstracts.


**IT IS ORDERED** that Arizona Department of Water Resources (“ADWR”) shall review Attachment I and provide to the Court by **March 18, 2024**, an estimate of the personnel hours to develop a single map, and schedule for developing and filing with the Court draft versions of all the maps listed on Attachment I by December 31,

1 2024. In light of notice requirements, maps may be filed separately or in groups.


2 **IT IS FURTHER ORDERED** that ADWR will need only give notice to parties

4 Once the Court has reviewed ADWR's proposed schedule, further instructions  
5 on how and when parties may file comments regarding the draft maps will be provided.
