20 This case, W1-00-000106,<sup>1</sup> was initiated on November 27, 2017, for the purpose  
21 of delineating the subflow zone for the Verde River watershed, and subsequently for  
22 proceedings related to *de minimis* standards in the Verde River watershed. The initial  
23 Court Approved Mailing List (“CAML”) for this case was created from case W1-00-  
24 001234,<sup>2</sup> *In re The General Adjudication of all Rights to Use Water in the Gila River*  
25 *System and Source*. As objections and motions to various reports have been filed, the  
26 CAML related specifically to W1-00-000106 has grown, however many parties remain on  
27 the CAML only as an artifact from the initiating order and have never substantively


2 Due to changes in Court technology, and to minimize the effort and cost associated

- 6 3. Parties who have filed a motion to intervene.


7 Attachment A to this order includes a list of all parties being removed as well as those
