Based upon the expected size of the Arizona Department of Water Resources (“ADWR”)s *Preliminary Hydrographic Survey Report for the Sycamore Subwatershed*, to be published in early March 2026, and the *Final Hydrographic Survey Report for the Sycamore Subwatershed*, to be published in early March 2027, the Special Water Master is limiting the documents to be filed with the Maricopa County Clerk of Court (“COC”) to just the following portions of the hydrographic survey reports (“HSRs”):

All general report information as well as all figures and tables that pertain to the general report information.


1 All remaining portions of the HSRs, including references, appendices, and all
2 individual watershed file reports shall not be filed with the COC but must be available on
3 ADWR's website with a link in the notice that leads *directly* to the report.

4 **IT IS ORDERED** that ADWR shall file with the Maricopa County Clerk of Court
5 only the general report, and any figures and tables that are associated with the general
6 report of the preliminary and final HSRs for the Sycamore subwatershed.


7 **IT IS FURTHER ORDERED** that ADWR shall make available on the agency's
