15 **CONTESTED CASE NAME:** *In re Subflow Technical Report, San Pedro Watershed*
16 **REPORT INVOLVED:** Groundwater Flow Model of the Upper San Pedro
17 Groundwater Basin Addendum, February 2025.
18 **DESCRIPTIVE SUMMARY:** The request for a continuance by Arizona Department
19 of Water Resources is **DENIED**. The status conference remains scheduled for
Thursday, February 27, 2025, at 10:00 am.


20 On February 24, 2025, the Arizona Department of Water Resources ("ADWR")
21 filed a Request for Continuance for the status conference currently scheduled for
22 February 27, 2025, to be rescheduled the following week. While it would certainly be
23 beneficial to have ADWR participate in the discussion, rescheduling at this late date
24 presents multiple challenges. Beyond the Court's schedule for the next few weeks,
25 there are many parties interested in this issue who have planned for many months to
26 attend this conference. Rescheduling at this late date affects more parties adversely
27 than keeping with the current date.

28 The expectation of this conference is a robust conversation by all parties

1 regarding what information in the February 2025 Addendum they believe remains
2 deficient. It is highly unlikely that attendance by ADWR would be able resolve those
3 concerns during the conference. Irrespective of who participates in the conference,
4 ADWR will be provided with a detailed list of additional information they will be
5 expected to provide and a reasonable timeframe for completion.

6 **THEREFORE, IT IS ORDERED** ADWR's request for a continuance is
7 **DENIED** and the status conference remains scheduled for **Thursday, February 27,**
8 **2025, at 10:00 am.**
