CONTESTED CASES**


CONTESTED CASE NAME: *In re Forest Service – Anderson Development Corp.*

Contested cases **W1-11-003442 and W1-11-003452** involve stock watering uses in the Deer Creek allotment within the Coronado National Forest investigated by watershed file reports (“WFRs”) 115-10-014 and 115-10-BCB-001, respectively. These cases were consolidated with W1-11-002583 on May 20, 1993. Contested case W1-11-2583 was subsequently consolidated with W1-11-000019 on December 3, 1993. In order to appropriately consider the potential water rights claims for each WFR, contested cases W1-11-003442 and W1-11-003452 must be deconsolidated. Accordingly,

1           **IT IS ORDERED** that contested cases W1-11-003442 and W1-11-003452 shall  
2 be separated from W1-11-000019 and W1-11-002583. All documents filed in W1-11-  
3 003442 or W1-11-003452 shall be filed only in their respective case files.
